



WAYS TO GIVE

This flyer outlines options for making a gift to the Faith, Family, Future 2 (FFF2) Campaign, with a brief explanation of each option. We hope you find this information helpful as you prayerfully consider how you can share your blessings with Christ the Lord Lutheran Church & School (CTL).

GIFTS BY CHECK OR CASH: To make a gift by cash or check, please place your gift in the offering envelopes in your offering box labeled "Capital Campaign". Please include the designation to FFF2 in the check memo line.

ONLINE GIVING: Make a one time or recurring gift by electronic funds transfer (EFT) from your bank account or credit card through the CTL online giving site at christthelordbrookfield.org/offerings. This is a secure online giving site administered by Vanco Payments. Giving online is easy, safe, enables you to write fewer checks, and allows you to view your complete online giving history. Contributions can be debited automatically from your checking or savings account or processed using your credit or debit card. Choose the online giving option "Capital Campaign – FFF2" to make a gift to the campaign.

GIVE+TEXT: Vanco Payments also provides the option to give by text. Simply send a text message to 855-706-1411 (CTL's Give+ Text number) with the amount that you would like to contribute (example: 25). Within a few minutes, you will receive a text response with a link to register. Click on the link and enter your credit or debit card information. Once that is completed, you'll receive a text verification and receipt for your donation via email. For future giving, send a text with the amount you want to give and it will process automatically! You can even text "repeat" to make a recurring donation. If you would like to designate a text gift to the FFF2 campaign, please follow the amount with "FFF2" (example: 25 FFF2).

VANCO MOBILE APP: Vanco also offers an app option to give via your mobile device. You begin by downloading the Vanco Mobile app from the App Store or Google Play. Within the app you can search for Christ the Lord and select that as your home church. Once registration is completed, you are set to continue giving through the app. Specify the amount you wish to give, the fund (FFF2 is an option), and your payment method. You are also able to add an additional amount to cover the donation processing fees.

GIFTS OF STOCKS, BONDS, OR MUTUAL FUNDS: If you would like to make a gift of stocks, bonds, or mutual funds to CTL, please contact Cory Moudry to make appropriate arrangements for the transfer.

GIFTS FROM A DONOR ADVISED FUND: If you would like to make a gift to CTL from a Donor Advised Fund (DAF), please contact Cory Moudry in advance of making that gift. Please also request that your fund administrator include your name and the designation to FFF2 when sending your gift.

QUALIFIED CHARITABLE DISTRIBUTIONS FROM AN IRA: The IRA Charitable Rollover tax incentive allows individuals aged 70½ and older to donate up to \$100,000 annually from their Individual Retirement Accounts (IRAs) to qualified charitable organizations like CTL, in place of their required minimum distributions (RMDs), and without having to count the distributions as taxable income. Donors must be 70½ years old or older when the distribution is made, and the distributions must be made directly from the IRA trustee payable to the charitable organization. The qualified charitable distributions (QCDs) can be made in one lump sum annually, or as a recurring gift. Please contact Cory Moudry if you plan to make a gift to CTL through a QCD. Please also request that the IRA trustee include your name and the designation to FFF2 when sending your gift.

GIFTS FROM THRIVENT CHOICE: The Thrivent Choice program gives eligible members of Thrivent Financial the ability to recommend where some of Thrivent's charitable outreach funds are distributed annually, using a vehicle called Choice Dollars®. Members become eligible for Thrivent Choice Dollars based on their insurance premiums, contract values and Thrivent volunteer leadership. You can access your Thrivent account at thrivent.com/thriventchoice, call Thrivent at 800-847-4836, or contact your Thrivent financial representative to learn how many Choice Dollars you may have available. Please notify Cory Moudry or Vickie Walther to coordinate this giving option and to direct your Thrivent Choice dollars to FFF2.

EMPLOYER MATCHING GIFTS: If your employer has a matching gift program that matches gifts made to educational non-profit organizations, then your gifts to the FFF2 campaign made payable to Christ the Lord Lutheran School could be eligible for an employer match. Employer matching gifts are not applied directly to your personal campaign commitment but are a great way for you to multiply the impact of your gifts to the campaign. If you will be requesting an employer match, please notify Cory Moudry or Vickie Walther at the time you make your gift to be matched.
